Janis Conallon w/ Safe and Sound: I have a quick report, I would like to extend our thanks to Deputy Director Zighera, who participated in our Family Services Week last week. By participating in a roundtable discussion about childcare for children with special healthcare needs. We were really grateful for the dynamic conversation between families, policy makers and other leaders in the city. We want to keep our eye on the budget we are looking at what we think is a \$1.2 million difference. It's a drop in what FRC have been using to meet basic needs and as we know needs have been increasing. That money is really important, so we will continue to have that conversation. The figure might change but that's what it looks like right now, we appreciate your attention to that.

Maria Luz Torre w/ Parent Voices: We would like to thank the Commission for this opportunity to speak, and I know this is a commission meeting and I know you can't answer questions from the public. But we have questions about the process of giving public comment. Because we feel that giving public comment at the beginning has its pluses but also its minuses. We do not know what we are going to comment on, if you discuss something and we have something to say about it that kind of gets lost. We hope that there is somehow another opportunity to give public comment on specific agenda items instead of just at the beginning. At the last meetings the parents were like "what that's it".





Dr. Joana Quiroz w/ Felton Institute: I would like to underscore the critical importance of continued investment and partnerships between ECE and FRC providers. As you know these 2 pillars form the foundation of a robust system if care and safety net for families in our community. We know that ECE programs lay the groundwork for a child's future providing essential ECE experiences that are fundamental for their growth and their development. Meanwhile FRC centers offer invaluable support and resources to families ensuring that they have access to assistance and services that they need in order to thrive. By investing in and fostering partnerships between ECE and FRC we are not only investing in the wellbeing of our children but also the strength and resilience of our entire community. Focusing on these 2 generations creates a holistic support system that uplifts families and empowers them to overcome challenges, achieve their goals and contribute positively to society. Today we urge you to restore the 1.2 million in the DEC budget for family support services.

Commissioner Armstrong: Maternal, Child and Adolescent Health is kicking off a needs assessment. The Title V Block Grant MCAH Needs Assessment plays a crucial role in assisting states to identify and address the most critical needs among women, infants, children, and adolescents with special health care needs. Title V Local Needs Assessment data will be available in April. Community input about local health problems will play a pivotal role in the prioritization of 15 health problems, which will be reported to the California Department of Public Health (CDPH) in June 2024. The 15 health problems will set the stage for the State Title V 5-Year Scope of Work.

Commissioner Lambert: I attended the DCYF Family Resource Fair at the County Fair building, and it was phenomenal. Many resources, providers, CBO's, summer activities and city departments were in attendance. Maria's team did such a great job, and the city is a great place to raise families.

Executive Director Mezquita: DEC reinforced Mayor Breed's Children and Family Recovery Plan strategies. At a press conference held at the Good Samaritan, Mayor Breed and Supervisor Melgar uplifted DEC's impact on young children, families, and the system of care, highlighting the importance of the city's investments in child, family, and ECE workforce support.





Predictors of Kindergarten Readiness

(From 2007, 2009, and 2015 Assessments)

Research shows that being ready for kindergarten is a key educational benchmark that leads to continued success in future years.

All children need the support of family, community, and systems to be ready for kindergarten.

These three solicitations address almost all the factors associated with increased school readiness.





San Francisco Family Resource Center Initiative: For over a decade, FRCS have demonstrated ability to build community and social connections; increase families' engagement in schools and communities; enhance parenting capacity and confidence; support parent/child nuturing and bonding; and link families to resources and services in times of crisis.

Entities will apply as either neighborhood-based or city-wide population and will respond to Four Service Categories:

- Responsive Relationships: Family members learn from one another and have nurturing, supportive relationships inside and outside family resource centers. Services reduce social isolation and increase social supports.
- Parent Self-Efficacy: Parents understand developmental milestones, believe they can influence their child's development, and use practices that promote milestone achievement. Services promote understanding of child development as well as supporting parental resilience.
- School Readiness and Success: Children enter kindergarten with the cognitive, social/emotional, and physical skills that support school success. Services include understanding about the social-emotional competence of children.
- Stress Mitigation: Parents/caregivers have the information, resources, and connections to peers and professionals to successfully raise their children in San Francisco. Services connect families to concrete supports in times of need.

Early Intervention and Specialized Services System of Care RFP is intended to form a consolidated Early Intervention service system from complementary parts that were more siloed in previous grant-making and to enhance service components for children with moderate to high risk for developmental delays.

Entities will apply in one or multiple Service Component Areas:

- Children with Special Health Care Needs and Early Intervention Family Resource Center (one provider)
- Centralized Access Point (one provider)
- Developmental Play Groups (multiple providers)
- Care Coordination (multiple providers)



Mental Health Consultation Initiative: services are focused on improving the capacities, skills and understanding of adults of themselves and thereby impacting children's social-emotional needs and development.

All entities will respond to three categories of services:

- Mental Health Consultation
- Early Intervention & Mental Health

BACKGROUND

First 5 San Francisco (CFC), which became a division of the county's Department of Early Childhood (DEC) in fiscal year 2022-2023, is required to submit a two-year budget to the City and County of San Francisco's Controller's Office every February. DEC is primarily a grant making agency which awards funds to organizations to implement activities to achieve the objectives of the DEC Strategic Plan. CFC's budget, allocation of Proposition 10 funds, and corresponding initiatives, are shaped by the goals and objectives set forth in the DEC Strategic Plan. The allocation of Proposition 10 funds must also be aligned with the long-term financial plan.

In order to address the new realities of grant-making with blended funds as part of a large Department and realize our number one priority of investing public dollars back into the community as efficiently as possible, staff is recommending a Funding Policy and Procedure that aligns with the practices of other First 5 Commissions of similar size and county configuration.

Policy Name:	First 5 San Francisco Funding Policy & Procedure
Effective Date:	May 15, 2024 (pending approval)

Purpose

To establish a policy and procedure for First 5 San Francisco, a division of the San Francisco Department of Early Childhood, to allocate state Tobacco Tax (Proposition 10) funds for programs and services.

This policy will replace the Commission Approval Limits policy (3/6/2024) and the Annual Budgeting Policy & Process (6/1/2016).

Background

First 5 San Francisco (CFC) which became a division of the county's Department of Early Childhood (DEC) in fiscal year 2022-2023 is required to submit a two-year budget to the City and County of San Francisco's Controller's Office every February. DEC is primarily a grant making agency which awards funds to organizations to implement activities to achieve the objectives of the DEC Strategic Plan. CFC's budget is shaped by the goals and objectives set forth in the DEC Strategic Plan. The allocation of Proposition 10 funds must also be aligned with the long-term financial plan.

Policy

Proposition 10 money resides under the Children and Families First Trust Fund (Trust Fund) which belongs to the City and County of San Francisco (City) but gives exclusive authority of the Trust Fund to the San Francisco Children & Families First Commission per the San Francisco City Attorney memos dated May 16, 2000 (appropriation memo) and October 2, 2000 (expenditures memo).

Proposition 10 funds shall only be used to supplement existing levels of services and not supplant state or local General Fund money for any purpose per CFC's Supplantation policy. The Commission will review the allocation of the Trust Fund money as part of its oversight and stewardship responsibilities under DEC. The level of review and approval is completed during the City and County of San Francisco's annual budget and appropriation process. The review and approval process for fund allocation is set by the Commission and can be evaluated and amended by the Commission.

Procedure

The Commission has designated the staff of DEC to allocate the Trust Fund money appropriately to the programs and/or initiatives outlined in the most current strategic plan through the City's annual budget and appropriation process.

The staff will input two-year annual budgets into the City's budget system. The CFC division budget will lapse at the end of each fiscal year. Use of the Proposition 10 fund balance (aka Preservation fund or

Policies & Procedures



rainy-day funds) will be subject to the approval of the Commission during this annual budget process. Any unspent funds determined at the end of the annual audit will be returned to the fund balance for future use.

The Commission authorizes the staff to perform the following:

- Issue solicitations using the City's procurement process to determine agencies or organizations capable of providing the services or programs outlined in the DEC Strategic Plan.
- Draft two-year division budget using information from the strategic plan, current solicitations, prior years' audit reports, and the long-term financial plan to allocate funds for administrative and programmatic expenditures.
- Include program initiative or contract funding recommendations derived from the solicitation process. Funding allocations must be approved by the Commission. The Commission's approval of the annual budget fulfills this requirement.
- Include any projected usage of unspent funds and/or delayed spending from the current fiscal year into the new division budget.
- Present final draft of the two-year division budget (Proposition 10 only) to the Commission for comment and review.
- Present final revised two-year division budget (Proposition 10 only) to the Commission for approval.
- Amend the division budget as needed and present amendments to the Commission for review and approval if changes are significant and/or over the original approved base amount.
- Close each year's division budget at the completion of the annual audit.

If need be, the Commission can form an ad hoc Fiscal Committee. The Fiscal Committee shall consist of members of the Commission appointed by the Chair.

The Fiscal Committee is responsible for reviewing and making recommendations to the Commission on all Proposition 10 financial matters, including: (1) overall financial planning, including matters relating to the budget and monitoring expenses; (2) all proposals before the Commission involving expenditures of Trust Fund moneys including, but not limited to Requests for Proposals, grants and contracts; and (3) any other matters referred to it by the Commission.

When there is an ad hoc Fiscal Committee, it can approve Proposition 10 awards up to \$75,000 if it was not part of the original approval of the annual budget. The recommendations of the Fiscal Committee may be placed before the Commission by way of a Consent Calendar.

The consent calendar is an action item on the Commission agenda, which allows the Commission to take multiple actions as a single agenda item without discussion. The Fiscal Committee members approved items to be placed on the Commission Consent Calendar. Voting members of the Commission may remove an item from the Consent Calendar. In the event of a staff error, the Executive Director may instruct the Chairperson of the Commission to remove an item from the Consent Calendar.

BACKGROUND

First 5 San Francisco (CFC) is now only a division under the San Francisco Department of Early Childhood (DEC). The Children and Families First Commission has authority over San Francisco's portion of the state's Tobacco Tax funds and the funds that any other revenue that is directly received by CFC. DEC has presented the full department budget at the following meetings:

- January 17, 2024 Joint First 5 and Early Childhood Children's Oversight & Advisory Committee meeting
- February 13, 2024 Joint First 5 and Early Childhood Children's Oversight & Advisory Committee meeting
- February 14, 2024 Childcare Planning and Advisory Committee

The Commission will be approving final draft for the CFC Division which includes the following for 2024-25:

- Total FY25 budget is \$22.2 million.
- The budget includes the use of \$3.5 million from the sustainability fund.
- The Inclusion Training and Technical Assistance program has been fully moved to the ECE division.
- Prop 10's portion of the Early Intervention Family Resource Center has been shifted to Child Health.
- The Mental Health Consultation initiative will be directly administered by DEC instead of DPH.
