- how we hold the impact of the "fixing families" model of the past within the work
- The topic of supporting marginalized groups who do not see themselves represented in intervention methods was addressed.
- Using the data as a justification for the priorities communicated by the Strategic Plan was suggested.
- An example given was that in classroom contexts when providing interventions to specific, communicating the context of why it is needed creates an understanding.
- Abundance versus scarcity, moving out of an "us versus them" perspective on resources.
- Releasing feelings of overwhelm and replacing them with action.
- Universal Childcare is the goal which means a piece of the pie for everyone, everyone gets what they need regardless of ability to pay.
- Review the purpose of the San Francisco Department of Early Childhood

### Group 3

- Example of the Library Commission might be helpful to this joint governing structure Library Commission approves policy, approves budget, and approves the hiring of the Director. - EC COAC appears to have a little more flexibility, whereas Commission must go
  by the by-laws. There may be an opportunity in a merged group to be stronger,

that data and sharing it back with hospitals and with other public health entities, but also the birthing people. People can go on the Irth app and see where other working people with their same marginalized identities have had good experiences. And so, because of a generous donation from the Department of Early Childhood. We're having a concerted Irth app effort here in San Francisco, starting in November. The Irth App is hiring a few doulas to actively solicit reviews from people who have given birth recently across San Francisco. And they're going to do that for 9 months. so that we can kind of have a picture of what is working across all 5 of our birthing hospitals in San Francisco. We are going to have an information session, in October, or that people soon I'll invite both groups. It is open to all.

This model has seen success. We have community members start childcare business throughout the Bay Area we're looking to expand. We graduated 39 graduates that can go directly into the classroom. and I want to thank Monica for having spaces available for some of our graduates. They can further their education at San Francisco State, and get more units to become administrators, or they can go to our business incubator program and get mini grants to start their own businesses. ### **Public Comment**

Dr. Yohana Quiroz (Felton Institute)-Good afternoon, I am so glad to hear that the early childhood Mental Health initiative is moving on to be under the department of early childhood. However, I am deeply concerned to hear that there is no additional funding for this very critical work. Especially in the face of substantial and escalated crisis and mental health. We know that the wellbeing of our youngest community member is at stake, and we cannot afford to ignore the urgent need for resources in this critical area. We know that the mental health challenges faced by young children and their families have grown exponentially, and we recognize that the early intervention is vital to prevent long term consequences without sufficient funding, we risk leaving countless children and families without access to the support and services that they need. We have given this feedback to the department of early childhood around the in adequate funding that is available right now for programs serving primarily black and brown children, and we urge the department of early childhood to figure out from props or any other resources to allocate additional resources for this very important initiative. Not only are the children and families being challenged, our workforce is also dealing with lots of challenges. Thank you.





- Strongly incentivized segregation




# Redlining 1932-1968

- Home prices in suburbs soared post-WWII. Blacks excluded from this wealth accumulation










# Urban Renewal 1948- present

In 1948, San Francisco officials declared the Fillmore, a largely African American neighborhood, to be "blighted" under the California Redevelopment Act of 1945

### **Enacting Ordinance** Overview

- The San Francisco Department of Early Childhood's enacting ordinance (FILE NO. 220808) went into effect on October 8, 2022. It evolves and expands publicly appointed oversight for San Francisco's early childhood system of care.
- The Department must report to and staff two oversight bodies: The First 5 Children and Families First Commission (CFC) and the Early Childhood Community Oversight and Advisory Committee (EC COAC).





**CFC Charge** 

- Promote, support, and improve the early development of children from the prenatal stage to five years of age
- Carry out the provisions of the California Children and Families First Act of 1998
- Decision-making authority over the County Strategic Plan, San Francisco Children and Families First Trust Fund allocations, and associated State Audit Report, and State Annual Report





- Recommendations on early care and education programming and initiatives
- Recommendations regarding the Early Care and Education for All Initiative and the Babies and Families First Fund (Baby Prop C)
- Recommendations regarding the Department's Strategic Plan and other areas of policy, planning, collaboration, and strategic partnerships related to providing early care and education for children ages zero to five in San Francisco.





Joint Charge for DEC's Publicly Appointed Bodies

While the CFC and EC COAC have differing membership, scopes, and authority, the Department's enacting ordinance requires significant collaboration between the two bodies including joint sessions, recommendations, and formal reports. These collaborative requirements fall into three categories:

- 1. Public Budgeting
- 2. Strategic Planning
- 3. Early Care and Education For All Initiative Accountability
