# 4. General public comment

Jenny Pearlman from Safe and Sound formally w/ Family Services Alliance: I want to provide comments on ongoing discussions around the budget and to reiterate that we are appreciative of the funding that has come out and additional funding for basic needs. But though that funding for basic needs is not the upcoming grants for FRC's those grants were significantly more. And we are continuing to advocate restoration planning for the enhancement grants in the ECE community. I took a letter to the department and to Director Mezquita from some of those key ECE members saying that they support that funding for those enhancement grants coming from baby Prop C. We believe very much that is simple for basic needs, families, management. We have talked to members of the Board of Supervisors and are hearing from actual organizations that may actually impacted if these enhancement grants are not restored, thank you very much.

Jadma Dudek w/ Family Services Alliance: I'm the director of Family Resources at La Raza Community Resource Center. I'm here to to second, what Jenny has commented in regard to the need not to have cuts when it comes to family resources. Every day we have folks walking into our offices that have arrived here. you know, less than a year. With a lot of health issues, with a lot of mental health the

shelters and the food banks are all at capacity. We are not in a place to be considering any cuts of funding for the family resources and the family enhancement grants. If we want to prioritize a generational and community approach to address the issues of the families, we need to make sure that the enhancement grants are not reduced. We have families that I sleep in on the streets because there are no shelters for them families asking if you know they can maybe just put up a tent if the city might be able to find a site for them to have their tents at. Families that were living in an RV in the sunset, and are displaced now, having to look for a new place to live. Families are in conditions where they have no running water, where they have none of their basic human rights and just basic health needs in order to thrive in a community where we have folks driving cars that are over \$100,000, we have millions of dollars being used.

Vanessa Bohm w/ CARECEN: Good afternoon. My name is Vanessa Boam. I work with the Central American Resource Center, CARECEN SF. We're part of the Family Resource Center Initiative in San Francisco and part of the Chicano, Latino, Indiana. Family Resource system and the Mission Family Resource Center Collaborative and just want to echo what Jenny and I believe Jadma have already mentioned. The community members that we serve are still facing such extreme economic crisis. We are seeing just as many the family resource centers, so many homeless families coming through our doors, looking to get connected to housing. emergency housing shelters. Oftentimes they are already on the wait list and are just waiting to get connected to a shelter and so they come to our services and our center to link with other resources. We've used the enhancement funds to buy food cards for families, to buy toiletries, for money to wash their clothes, baby supplies. You name it. We have used enhancement funds to really connect families with to help meet that their basic needs, as we understand it, there is funding. There's this baby prop C funds that could be used to restore this funding. And we're advocating for that funding to be restored. This is certainly not a time to be taking away resources from families that most need it. I want to echo that advocacy around keeping hold the other enhancement dollars that really helped us help families meet their basic needs. Thank you.

Yensing Sihapanya w/ Family Connections Centers: Good evening. I want to echo what my colleagues have already said. My name is Yensing. I'm the executive director of Family Connection Centers. We run family resource centers as well as early care, after school program, summer camps, all that good stuff in the city of San Francisco. We serve over 2,400 children and their families every year, 95% of which are low income. We are so excited that the department has released their awards for their resource center initiative. The fifth cycle. It's going to be amazing. But, like my colleagues mentioned, what's not going to be part of the budget for next year. Are these enhancement grants? For 1.8 million dollars we are providing for 10 languages that are helping families out in every corner of the city, homeless families with children with special needs, African American families. At Family Connections it pays for one of the few Vietnamese speaking case managers in the city. It pays for the 300 bags of groceries that we just gave away on Friday, and for many of us on July 1st, we don't know what we're going to do. We don't know how we're going to transition the hundreds of families we have in case management, the hundreds of families that are receiving food and the hundreds more families they're receiving mental health consultants. We know that there is funding in the budget. We have the community support from our ECE partners around this. I just really hope that we can work together and



make sure that these services continue. Because when July comes, it's going to be really detrimental. If we're going to have to fire staff and stop these services. And thank you for all that you are doing, for advocating and I am hopeful that we're going make this happen. Thank you so much.





# **Early Learning Division (ELD)** Core Strategy Updates: Access& **Enrollment**

In the last two years, DEC launched ambitious new early learning initiatives which will continue to grow and develop:

- Expanded eligibility for free, high-quality early care and education (ECE) to families earning up to 110% of AMI
  - Reduced the ECE "wait list" of families from 3,061 to 850 (-72%)
  - Increased the number of infants served from 2,020 to 3,111 (+54%)
  - Added 47 new family child care homes (+19%) and 20 new centers (+13%) to DEC's network of 469 high-quality ECE programs
  - Awarded more than \$13 million in 2022-23 to add over 550 new spaces

### **Early Learning Division (ELD)** Core Strategy Update: Workforce **Development**

Early Educator Support Grant:

- Educators are receiving 30-47% more in pay.
- Average Salary \$29.50 to \$37.00 per hour, based on teacher role/education. Approximately 1,200 early educators receiving grant funding pay augmentation.
- CARES 3.0
  - \$20 million annually allocated to fund stipends for wage gaps
  - Over 1,600 educators receive increase in compensation, with an average of \$12,336.
- DEC & Office of Economic and Workforce Development Partnership: recruitment of new early educators with a focus on African American early educators. Funding efforts total over \$1.6 million annually.

# **Child & Family Well-Being (CFW) Core Strategy Updates**

Family Resource Center Initiative: \$17.8 million to fund 25 grants

- Family Resource Center Initiative Proposals Received: 35 proposals representing 24 neighborhoods and 11 city-wide populations
- Early Childhood Mental Health Consultation Initiative: \$5million to fund 4-6 grants
  - · Early Childhood Mental Health **Consultation Proposals** Received: 4 proposals
- Early Intervention and Specialized Services System of Care: \$2.7 million to fund 9-11 grants
  - Early Intervention and Specialized Services System of Care Proposals Received: 18 proposals





### Child & Family Well-Being (CFW) **Strategic Priorities Updates**

- Parent engagement and input in initiative planning processes expanded significantly.
- Applicants were required to identify contract practices, policies and actions to ensure equity and address racism at multiple levels including among staff, within their organization, and within communities and systems. This will be used as basis for accountability moving forward.
- Initiatives include specific expectations for meaningful parent input and influence in decision-making structures.
- Currently planning to bring greater integration to the early childhood system of care for families navigating across service sectors.

# **Evaluation, Policy, & Communications** (EPC) Strategic Priority Updates

- - Increased staffing to support planning and build-out of new data systems and evaluation infrastructure for accountability
  - Facilitated internal planning with program divisions to develop preliminary logic models, data inventories, and research questions for every major initiative
  - Gearing up to release \$2 million/year RFP for data and evaluation services to support initiative evaluation, landscape analysis, data mapping and governance, and data systems development and management
  - RFP prioritizes implementation of work using racial equity lens, culturally and linguistically responsive methods, familiarity with San Francisco's diversity, and authentic, non-extractive representation in evaluation work.





### **Evaluation, Policy, & Communications** (EPC) Strategic Priority Updates

- Policy and Communications
  - Launched intensive communications and community engagement planning
- Implemented workgroup, gathered information and feedback through focus groups, surveys, community events, stakeholder listening sessions, key informant interviews, and staff (ongoing)
- Increased representation of voices from Black, Latino, indigenous, and Pacific Islander communities, multilingual families, and families with children with special needs
- Will ultimately inform new web site content, ways for parents to engage with DEC lightly or more deeply, marketing and outreach, and partnerships with grantees and other institutions

# **BACKGROUND**

First 5 San Francisco (CFC) is now only a division under the San Francisco Department of Early Childhood (DEC). The Children and Families First Commission has authority over San Francisco's portion of the state's Tobacco Tax funds and the funds that any other revenue that is directly received by CFC. DEC has presented the full department budget at the following meetings:

- January 17, 2024 Joint First 5 and Early Childhood Children's Oversight & Advisory Committee meeting
- February 13, 2024 Joint First 5 and Early Childhood Children's Oversight & Advisory Committee meeting
- February 14, 2024 Childcare Planning and Advisory Committee

The Commission will be approving line items 15, 18 and 24 of the final draft for the CFC Division which includes the following for 2024-25:

- Family Resource Centers (includes addbacks & pass-throughs)
- DPH Parent Training Institute
- DPH Health Screenings
- Total FY25 budget is \$22.2 million.
- The budget includes the use of \$3.5 million from the sustainability fund.
- The Mental Health Consultation initiative will be directly administered by DEC instead of DPH.
